- 6. Electronic bids must be submitted through PPMO "se-GP system www.bolpatra.gov.np/egp onorbefore12.00 hours on 2078/02/28. Bids received after this deadline will berejected.
- 7. The Technical bids will be opened in the presence of Bidders' representatives who choose to attend at 14.00 hours on 2078/02/28 at the office of Kapurkot Rural Municipality, Salyan.
- 8.
